

## TERMS AND CONDITIONS OF THE PROMOTION: WHAT TRAVEL MOVIE ARE YOU?

---

**1.- Organizing Company.-** The organizer of the promotion "San Fermin Pamplona" (hereinafter , the "Promotion" ) is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter " eDreams " ), with registered office at World Trade Center Norte PI 6, Moll de Barcelona, s/n, 08039 Barcelona, Spain and Spanish Tax ID number: B-61965778.

**2.- Location, date and time of the Promotion.-** This promotion will take place on eDreams' blogs in the UK (<http://blog.edreams.com/>), Spain (<http://blog.edreams.es/>), France (<http://blog.edreams.fr/>), Germany (<http://blog.edreams.de/>) and Portugal (<http://blog.edreams.pt/>), during the period between September 28, 2015 at 16:30h to October 2, 2015 at 14:00h BST (hereinafter "Promotional Period"). The prize draw will be done in eDreams' headquarters between 14:00 and 14:30 on October 2, 2015.

**3.- How to Enter.-** The promotion has been developed in Spain but is exclusively reserved for any person who meets the following requirements can participate: (1) be at least 18 years of age, (2) reside in Germany, Spain, France, Portugal or United Kingdom (hereinafter "Participants"). All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.

**4.- How the Promotion works.-** Participants should access the application hosted on Qzzr and on our blogs, with the name of "What Travel Movie Are You?". Once participants have entered the quiz, they will have to respond to the questions to get a final outcome. Participants will have to leave a comment in our blog post with their quiz outcome and email address to be included in our prize draw. Winners will be chosen through a Random system by numbering all participants on an Excel file of the games database. The prize is limited to one person.

**5.- Entry requirements.-** Only answers that relate to the theme proposed by the organizing company will be accepted. Obscene answers will not be accepted, neither will those which could harm the moral integrity of users in any way.

**6.- Prize.-** The Prize includes 1 camera [Polaroid Cube](#).

The total value of the prizes is **£79 / 92€**.

**7.- General Conditions for the Prizes.-** In the event that through no fault of the organizing company the prize cannot be delivered as scheduled, this will be replaced by another of similar features and value.

The prize can't be exchanged or transferred to anyone other than the official winner and can't be refunded for money or other packages.

**8.- Income tax.-** In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.

**9.- Announcement of the Winners.-** The winners will be announced on our eDreams blogs on October 2, 2015 and will also receive an informative email with instructions on how to claim their prize of the "What Travel Movie Are you" sweepstakes. The winner has 10 calendar days from the closing date of the contest to accept the prize and to send their contact details to the indicated address, otherwise the prize will be considered rejected and declared void.

In order to formalize the act of delivery of the prize, the Organizer will send a Letter of Acceptance of the Award which will have to be signed by the winner, as proof of reception.

The winning participants authorize eDreams to publicly post their full names on their websites and blogs for the next 3 months after the sweepstakes.

**10.- Personal Data.-** According to the Spanish Personal Data Law (Ley Orgánica 15/1999 of the Protección de Datos de Carácter Personal), we inform the Participants that the personal data provided will be added into a personal data file owned by the organizer. These data will be processed to assure the participation in the contest as well as to process the delivery of the prize, promotion and marketing purposes, which includes sending commercial communications by email.
