

TERMS AND CONDITIONS OF THE PROMOTION: "TRAVEL LOVERS"

1.- Organizing Company.- The organizer of this promotion (hereinafter "Promotion") is the Spanish legal entity, Vacaciones eDreams , SL – Shareholder Company (hereinafter "eDreams"), with registered office at Passeig de la Zona Franca, 191-205, 1ª planta, 08038 Barcelona, España and CIF number B61965778.

2.- Location, date and time of the Promotion.- This promotion will take place in a set of pages dedicated to "Valentine's Day" and they're hosted in eDreams' official websites:

During the period between 8h00 GMT of February 8, 2017 to 23:59 GMT February 28, 2017 (hereinafter "Promotional Period"). The prize draw will be held at eDreams' registered office between 12h00 and 16h00h GMT on March 2, 2017.

3.- Eligible participants.- Any person who meets the following requirements can enter this promotion: (1) be at least 18 years of age, (2) reside in United Kingdom, Spain, or France. All eDreams employees, partners, employees and/or their family members, may not participate in the promotion. Participation is free.

4.- How to enter.- Participants should access the "Travel Lovers" page where the Promotion takes place. Once inside the page, users will have to select their favorite city for a romantic getaway from a selection of 10 destinations and afterwards fill the contact form with their personal information (name, surname and email), which will be accessible during the Promotional Period. Once completed, participants will automatically enter the promotion's prize draw. Each user can only participate once. On the day of the prize draw, eDreams will select ONE (1) winner through a random system by numbering all participants on an Excel file of the promotion database.

5. Prizes.- The winner of this promotion will receive a prize that consists on a discount voucher worth THREE HUNDRED AND FIFTY (£350) to use in Flight+Hotel bookings in our dedicated website for users in the United Kingdom (<http://www.edreams.co.uk>)

General conditions for the Discount Voucher

- The discount voucher is valid exclusively for bookings made through eDreams, S.L. and can only be used for a sole booking for Flight+Hotel reservations.
- The discount code is not subject to a minimum purchase amount, so it can be applied to any "Flight+Hotel" reservation made through the eDreams website, regardless of the price of the same.
- However, if the amount of the reservation is less than £350, the winner will lose the difference and will not be able to apply the discount on future reservations. The code can only be applied once.
- The discount voucher is personal and non-transferable, so the winning participant must be the buyer and owner of the payment method used to apply the discount to his reservation.
- It is not possible to exchange the voucher totally or partially for its cash value.

6.- Income tax.- In regard to article 43.2 of the Spanish Law on Personal Income Tax, eDreams will not deposit the amount of the value of the prize in the winners account. However, the total value of the prize will be included in the Letter of Acceptance for the winners' tax obligations, if he/she had any.
